### **WE GOTTA FIGHT THIS,** FOLKS!

I think I'm going to go nuts. I already am, you say? OK, I'm going to go even nuts-er. These bureaucrats and government agencies drive me bonkers. The people who staff them produce nontangible products but instead absorb income out of our pockets. And what do we get for this enforced transfer of money from our pockets to theirs? Only a lot of hassle and grief, a lot of nitpicking, and usually demand for even more money in the form of fees (that are actually taxes).

Here are a couple of examples:

In a couple of days. I have to drive down the hill to the SB County offices to protest a \$400 fine for a simple single typo on the labels of two kinds of sandwiches. Then, a few days ago, we received a letter with the headline "DEMAND FOR PAYMENT". accusing us of being delinquent on our payment of annual fees (\$1143) to the California Water Resources Control Board (what a mouthful!). We had paid the fee and mailed

it between Dec. 21-24, but it was not processed by this agency until January 7, triggering their letter of delinquency and threats of fines and criminal charges.

My response to them will tell you all you need to know of my attitude toward such things: "Thank you for

delinguent invoice. Of course, your "accounting office records" that indicate that we have failed to pay the required annual fee' are so very accurate, and are not to be doubted. However, forgive us for having the audacity to take issue with your accounting office records, because in fact, the FEE HAS BEEN PAID! Please see the enclosed copy of our cancelled check, which you did not process until 1/7/19, probably because the "accounting office records" were on a paid holiday, at our (the taxpayers') expense. Have a nice day."

And then we have to pay the IRS a penalty of \$900 due to a story too long to tell here, but trust me (Linda Used Car Saleswoman), we do not deserve that penalty but have given up after a year of wrangling. I'm sure many of you know how that is.

So if I've gotten your juices

flowing a little, please keep them flowing long enough to attend the County Board of Supervisors' meeting on Tuesday, Jan. 29, at 10AM\*. The issue: what we've been fighting about for over two years – we do NOT want industrial scale solar projects carpeting our beautiful valley, no way, no how, nowhere.

The County has ducked and weaved like a boxer in dealing with us, managing to drag out the fight long enough for a number

of large solar projects to file applications so that if we ever do win our battle and get our way, they will be grandfathered into the old County requirements, giving the County what it wants (good relations with, and income from, unions). As usual, we are the losers.

Specifically, on Tuesday\*, the Board of Supervisors is

supposed to decide whether or not to adopt Policy 4.10 as recommended by the Planning Commission, which

simply says that these huge power generation projects are not to be located in communities with a Community Plan, which our community does have, or did, until the County altered the playing field. The Com-

"DUH", huh, to let us decide what we want to be?

Somewhere in the eleven years since we did that, the County diddled, renewable energy became (And it's not unrelated to my battles a factor, and unions with lots of clout and \$\$ entered the picture. All of a sudden, the County decided to dance to their tune, not ours. 
