They were waiting for us, since we were now late due to our side trip in San Bernardino. Across the table from us were the inspector who wrote us up, his boss, and a lady who was the Supervisor of something or other and wrote lots of notes of the proceedings. Their job was to convince us that we should agree to the charge, sign off, and save the trouble of a hearing. You kidding?? Drive all the way down there only to say, "Never mind"? We told them no way will we do that. We agree to the facts as described but not to the conclusion and penalty for a VIOLATION.

So they proceeded with our trial, er, hearing, before a "judge". She began by recording the date, time, etc. into a recorder, and said, "This is Thursday, Jan. 16, yada yada." I looked at the inspector boss to see if he also caught that she said
